RENTAL AGREEMENT/TERMS & CONDITIONS

1. A non-refundable deposit of 50% is required to hold equipment for date of event. For orders under \$100 full payment is required in advance. Please send a check and a signed copy of this document to Marblehead Tent, 40 Evans Road, Marblehead, Massachusetts. Full settlement on orders over \$100 is due at time of delivery. We accept cash and/or check. Please make checks payable to Marblehead Tent.
2. The lessee agrees to ensure that the set-up area for any equipment is free of debris and obstructions and that the surface is appropriate for the equipment being provided. A set up fee may be assessed if the area is not clear, and we reserve the right to cancel your booking if the area is not sufficiently clear of obstructions or unsafe for proper set-up and use. In cases such as this your deposit is non-refundable. We are happy to do a site reconnaissance in advance if you are unsure about the suitability of the site.
3. All rentals include equipment, delivery, setup, and teardown. A delivery fee *may* be assessed for deliveries outside of a 10-mile radius. This is assessed on a case by case basis and depends on the size of your order. You will be informed of this charge if there is one before you complete your order and pay your deposit.
4. For specific setup/delivery times, please call at least four days in advance. Otherwise, we will deliver as close to the assigned time as possible.
5. You may not sub lease our equipment unless specific pre arrangement has been made with Marblehead Tent. This includes selling tickets for inflatable amusement rides or selling goods from concession machines. In the event that this happens we reserve the right to immediately retrieve the equipment and you will lose all monies paid and may be subject to legal action.
6. In event of harsh weather or acts of God, (severe thunderstorm, hurricane, etc.), please evacuate the tent & do not mess with the tent. If anything happens, please call us & we will take care of it. We reserve the right to take the tent down to prevent equipment, persons, and property from any possible harm or damage. We also reserve the right to cancel any order in the event that harsh weather doesn't allow for setup, or will cause harm to any rented equipment, as well as persons or property. In this rare event, your deposit will be refunded in full.

7. In the event of bad weather such as heavy rain on the day of your event and you decide to cancel we shall do our best to accommodate your next preferred dates, dependent on our availability. If you do not wish to reschedule you will lose your deposit.

8. The lessee may inspect the equipment upon delivery for defects and may refuse to accept the equipment if they are not satisfied with the quality or state of the equipment. However once the equipment is set up and Marblehead Tent staff has left the lessee's premises, the lessee agrees that the equipment is in satisfactory condition and is from that moment forward responsible for any damage that may occur during the lease. Marblehead Tent asserts that all equipment it provides is and will always be in good working order appropriate for use and in the event a lessee refuses to accept delivery of equipment the deposit shall be non refundable.

9. The lessee is responsible for all equipment from the point of delivery until pick-up. The lessee will also take on full responsibility & will be held liable for any damages that occur to any/all equipment. Lessees will be charged for damaged, broken, lost, or stolen equipment at the replacement expense.

10. The lessee is responsible for the proper and safe use of all equipment provided by Marblehead Tent and will not hold Marblehead Tent liable for any injuries or damages that occur from improper use of equipment, or any unsupervised use of equipment by minors.

11. In the case that the lessee is renting a bounce house inflatable, by signing this agreement the lessee agrees that they have been properly informed of safe use of the equipment and have received a copy of the safety and instruction manual.

12. The lessee is responsible for calling Digsafe on 811 to ensure that the area is ok to have a tent set-up on.

13. Unless you have pre arranged for our clean up service, all rented equipment must be free of materials such as food, ribbon, tape, balloons, tablecloths, etc. prior to pickup, or a cleaning charge will be assessed. Please ensure tents have been cleared of all chairs, tables, dance floor, lighting rigs etc prior to pick-up or a charge may be assessed for additional labor or waiting time incurred by Marblehead Tent.

14. Damage to lawn or property may result due to vehicle and trailer weight, as well as stakes and other necessary tools to keep tent or inflatables stabilized. Please have sprinkler system labeled, and animal feces cleaned up prior to our arrival.

15. By printing, signing, and dating the line below, you adhere to the following terms and conditions as described above and indemnify, defend and hold Marblehead Tent, its owners and employees harmless from and against any and all liability and costs incurred by the indemnified parties in connection with any claim arising out of

any breach by you of this agreement or the harm/damage to persons and/or property caused by any/all equipment.
